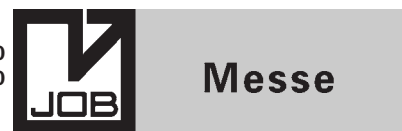

Special Conditions for Services provided by Bischof & Broel (Photography)

1. All photographs are protected by the laws of copyright and related protective rights dated 8.9.1965, such that the copyright remains with the photographer and the exhibitor is granted utilization rights only within the framework agreed by the parties concerned (negatives always remain the property of the ServicePartner).
2. In modification of § 16 of the copyright law, the transfer of printing rights does not include the right to photo-mechanical reproduction by the exhibitor.
3. For the handover of a selection of photographs, the utilization rights are transferred only to those photographs finally selected and purchased. Those not selected remain the property of the ServicePartner and are to be safeguarded and returned to the ServicePartner without delay following selection. Photographs issued for selection purposes, which are not returned within one month or are returned in a damaged state, will be invoiced by the ServicePartner.
4. Films, documents, layouts, display items, etc. given to the ServicePartner for processing will be carefully handled. Liability for damage, poor workmanship or loss is limited to the value of the material. A more extensive liability exists only if negotiated, or in case of the exhibitor giving written notification of the unusually high compensation level required when placing the order, following which the ServicePartner accepted the order.
5. The exhibitor is not entitled to compensation for delay in case of failure to comply with agreed delivery dates, where this is due to circumstances beyond the control of the ServicePartner; especially in cases of force majeure or poor weather conditions for outdoor photographs.
6. Claims of any kind must be registered by the exhibitor within 6 days of receipt of the photographs. Photographs are assumed to have complied with the order on expiry of this period of time.
7. Complaints concerning picture composition, selection of models, location and optical equipment used are not admissible in instances where the execution of the order was expressly left to the judgement of the ServicePartner.
8. Requests for changes received from the exhibitor or his representative during production will be charged to the exhibitor at the normal rates.
9. Unless otherwise agreed in writing, the exhibitor purchases the right to once-only reproduction for his own advertising use:
 - a) for printed material not intended for sale (leaflets, catalogs, etc.) or
 - b) for advertisements or similar publications.Reproduction for any other purpose (small or large posters, displays, packaging, calendars, on front covers, in text or picture parts of printed material, books, magazines, newspapers, postcards, etc. for sale) requires previous written consent and payment of the appropriate fees.
10. Photographs supplied remain the property of the ServicePartner until payment of the purchase price in full. The ServicePartner is entitled to retain material or other articles of property handed to him by the exhibitor until all fees, expenses and compensation for damage are settled.
11. Negatives and original slides are the property of the ServicePartner and are working materials required for producing copies of photographs or color prints. The exhibitor's entitlement is limited to copies and does not include negatives and original slides. The ownership of negatives and original slides will only be transferred to the exhibitor if specifically agreed and on payment of a fee at least equivalent to the price of the photograph. No responsibility can be accepted for the storage of negatives. The copyright for photographs remains unaffected, unless special arrangements have been agreed.
12. Exhibitors will be charged with a fee appropriate to the services provided (hourly rate, daily rate, agreed flat rate). All material and other incidental costs (modelling fees, requisites and their purchase, travel expenses, etc.) will be charged extra.
13. All articles handed over for photographing are to be insured by the exhibitor against damage, loss, theft, etc.
14. The exhibitor carries the risk for all circumstances beyond the control of the ServicePartner: e.g. weather conditions for outdoor photography, timely provision of products, availability of requisites (inasmuch as the exhibitor is responsible for their provision), travel restrictions and failure of representatives of agencies and advertising sponsors to keep appointments made.
15. A fee of 50% of the net fee plus other expenses may be payable in case of an order not being executed on the planned date for reasons which are beyond the control of the ServicePartner.
16. The name of the ServicePartner is to be indicated in every editorial reproduction. Failure to do so will result in an increase of at least 25% of the fee without proof of damages or the amount of damages proven.
17. The exhibitor is liable for damages for infringements of the ServicePartner's copyright. The minimum amount of compensation for each case of violation will be the usual price of the object of the contract. Further claims remain unaffected.
