Information on refund of VAT

If the headquarters of your company is not located in the Federal Republic of Germany and you would like to obtain a refund of value added tax, this can be arranged by our ServicePartner.

Refund of value added tax for foreign companies

All expenses resulting from your activity as a foreign exhibitor or visitor of a German exhibition company are subject to 19% VAT. You can apply for a refund of these taxes (e.g. costs of taxi travel, catering and drinks for your exhibition stand, stand costs such as rent and assembly costs, flights booked in Germany, expenses for petrol, hotel and restaurant bills, etc.).

Our ServicePartner charges you 15% of the amount refunded for this service, subject to a minimum charge of EUR 99.00. No fees are payable in advance.

Note

Not all countries outside the EU are eligible for a refund of VAT. Information on whether the conditions for a refund are fulfilled and on the procedure itself can be obtained from the ServicePartner shown below.
